## HOW TO USE:

AREAS	PEST CONTROLLED	RATE	HOW TO APPLY
Indoor and outdoor household areas	German Cockroach	<b>Initial Treatment or Extended Control or Heavy Infestations</b>  40 mL in 1 L water  <b>Maintenance treatment or short term control or Light Infestations</b>  20 mL in 1 L water	For crawling insects, apply as a course low-pressure spray to areas where pests frequent. For flying insects apply as a surface treatment using a fine spray to wet the surface. This product is NOT to be used to control fleas on animals or pests on garden plants, including fruit and vegetables. Application examples: 1L of prepared spray mix will treat 20 square metres. 5L of prepared spray mix will treat 100 square metres.  If a different water rate is required, adjust the dilution rate to ensure that 2mL of product is applied per square metre for initial treatments, extended control or heavy infestations; and that 1mL of product per square metre for maintenance treatments, short term control or light infestations.  Use the higher rate for ant control where population numbers are high.

## HOW TO PREPARE

This product control insects by contact action and ingestion. When applied as a surface spray, the product offers long residual activity. To obtain best results all surfaces should be treated, especially cracks, crevices and infested areas. A higher volume of water may be required on very absorbent surfaces. Apply to the point of run-off only.

Shake or invert the container before opening. Carefully measure the required amount of product and add to water in the sprayer and mix thoroughly. Do not mix more spray than can be used on the day of mixing. Thoroughly clean out sprayer after use.

## CAUTION

DO NOT spray directly on humans, pets, exposed food, food preparation areas or food utensils.

If using inside the home evacuate areas to be treated. These areas can be re-occupied once spraying is completed.

**Before use** – remove or cover all exposed foodstuffs; cover all dishes and utensils and places where food is prepared or stored.

Cover or remove bird cages or fish tanks during spraying.

**After use** – thoroughly ventilate treated area. Clean up thoroughly before processing/serving resumes.

DO NOT allow chemical containers or spray to get into drains, sewers, streams or ponds.

## STORAGE AND DISPOSAL

Store in the closed original container in a cool, dry place out of the reach of children. Do not store in direct sunlight. Dispose of empty container by wrapping in paper, placing in a plastic bag and putting into the garbage.

**SAFETY DIRECTIONS**

Harmful if swallowed. May irritate the eyes and skin. Facial skin contact may cause temporary facial numbness. Avoid contact with eyes and skin. Avoid inhaling spray mist. When preparing spray wear cotton overalls buttoned to the neck and wrist and a washable hat, elbow length PVC gloves. Wash hands after use. After each day's use wash gloves and contaminated clothing.
