MIXING To ensure even mixing, half fill spray tank with clean water and add the required amount of this product. Agitate thoroughly, then add the remainder of water. Boom Sprayer Calibrate the machine before use to ensure that the correct application rate is obtained. Check height of boom above the crop to ensure that the spray is evenly distributed. Aerial Application

Apply a minimum of 22 litres of water per hectare or 30 litres of water per hectare if tankmixing with diclofop-methyl. Markers should always move upwind before aircraft passes overhead. Application by micronaire equipment may give variable results.

EQUIPMENT MAINTENANCE

After use wash application equipment thoroughly with Spraymate Tank & Equipment Cleaner and rinse several times.

COMPATIBILITY

This product is physically compatible in the spray tank with one of the following herbicides or insecticides in wheat and barley only:

metsulfuron-methyl (600 g/L), diclofop-methyl (500 g/L), dicamba (500 g/L), MCPA, dimethoate, omethoate, endosulfan or chlorpyrifos.

When mixed with metsulfuron-methyl or dicamba, do not apply to cereals undersown with lucerne. When mixed with

diclofop-methyl, do not exceed 1.4 litres of this product per hectare. Observe all instructions on the mixture partner label. For weed resistance management Superway Buffalo Soldier Selective Herbicide is a Group C and Group I Herbicide. Some naturally-occurring weed biotypes resistant to Superway Buffalo Soldier Selective Herbicide and other Group C and Group I herbicides may exist through normal genetic variability in any weed population. The resistant individuals can eventually dominate the weed population if these herbicides are used repeatedly. These resistant weeds will not be controlled by this product or other Group C and Group I herbicides.

PROTECTION OF CROPS, NATIVE AND OTHER NON-TARGET PLANTS
